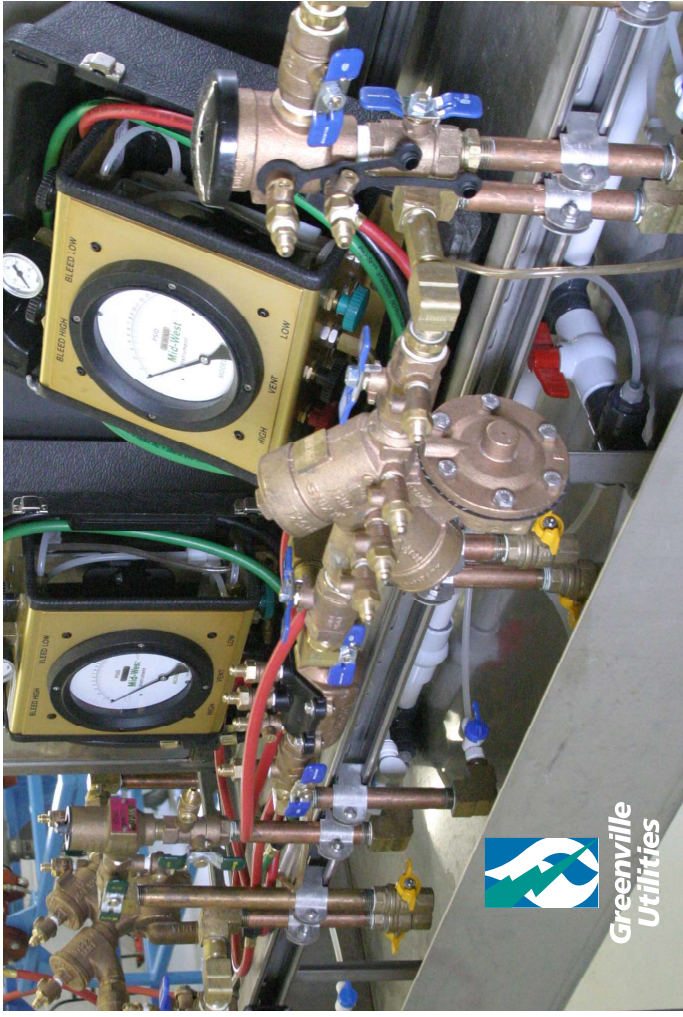

## Cross Connection Control and Backflow Prevention Assembly Tester Course

**March 14, 15, 20, 21, and 22, 2024 (8 a.m. - 4 p.m.)**

This is a five-day course. Cost: \$120.00. Price includes study guide and handouts.

Participants are requested to bring a flathead screwdriver and a towel. Class instruction will be conducted by Deanna Castellow, GUC Cross Connection Control Officer. Mrs. Castellow is also a Limited Backflow Tester for the state of South Carolina and holds certification in Backflow Prevention Testing and Cross Connection Control by the NC AWWA. She is also certified by the TREC Center at the University of Florida as a Backflow Repair Technician and Cross Connection Control Program Manager.

# It's Important You Attend

---

Cross-connections may appear in many subtle forms and unsuspecting places. Unprotected hazardous cross-connections can allow backflow to introduce pollution or contamination into Greenville Utilities' distribution system. Greenville Utilities recently revised the backflow section of our regulations to ensure cross-connections are protected to eliminate, as much as possible, potential dangers to all of our customers.

Effective January 2002, Greenville Utilities will no longer test Backflow Prevention Assemblies. Commercial and Irrigation customers will be required to contract GUC approved certified backflow testers to test each assembly upon installation and annually thereafter. To become certified, a tester must successfully complete a GUC approved Backflow Prevention Assembly Testing School and pass both a written and a practical exam.
