WATER RATE SCHEDULE W-6
BETHEL SERVICE AREA - OUTSIDE CORPORATE LIMITS

I. APPLICABILITY

This Water Rate Schedule is applicable to all water customers outside the corporate limits of Bethel and within two miles of the contiguous corporate limits of Bethel. Mobile home parks and apartment complexes served through master meters shall be classified as residential. This schedule is not applicable to customers inside of the corporate limits of Bethel.

II. METER READING AND BILLING

Each water meter shall be billed separately. Compound meters, or parallel turbine meters used in lieu of compound meters, shall be billed by combining reading of both registers. Split billing of water meters will not be permitted.

III. MONTHLY CHARGE

The monthly charge shall be the sum of the Base Facilities Charge, Volume Charge, and Monthly Surcharge as follows:

1. Base Facilities Charge: The monthly Base Facilities Charge for each metered service, regardless of volume usage, shall consist of a meter charge based on the size of the customer's meter.

2. Volume Charge

(a) Non-Irrigation Volume Charge

The monthly Non-Irrigation Volume Charge shall be based on the monthly metered water usage by customer class (i) Residential (ii) Commercial (iii) Industrial, at the following rates per thousand gallons:

- (i) Residential - \$8.25 per thousand gallons
- (ii) Commercial - \$7.25 per thousand gallons
- (iii) Industrial - \$4.44 per thousand gallons

(b) Irrigation Volume Charge

The monthly Irrigation Volume Charge shall be based on the monthly metered irrigation water usage at the following rates per thousand gallons:

- (i) Residential/Commercial – \$12.37 per thousand gallons
- (ii) Industrial – \$7.98 per thousand gallons

3. Monthly Surcharge: The Monthly Surcharge, for each metered service shall be a fixed monthly charge, regardless of volume usage or customer class.

- (i) Residential/Commercial/Industrial – \$16.41 per month

IV. Conservation Rate (To be implemented at a later date)

A Conservation Rate of \$12.37 per thousand gallons will be charged for that portion of a customer's usage that reaches or exceeds four (4) times the average winter consumption. This rate is applicable to residential and irrigation customers during the months of June through September. The average winter consumption for residential customers is defined as the average October through February usage for residential customers by meter size.

V. MINIMUM MONTHLY CHARGE

The minimum monthly charge shall be the sum of the Base Facilities Charge and Monthly Surcharge.

VII. PAYMENTS

Bills are due when rendered, and subject to a 1% penalty if not paid by the due date. For additional information, refer to Utility Regulations, Part D, Customer Service Policy.
