- 1. Who is the current broker and what is their fee? The question is not relevant to the RFP submittal.
- 2. Who is the current Claims Administrator for the self-insured workers compensation. Should the claims administration be included in the bid?
 - A. Greenville Utilities Commission has a separate agreement with its Workers Compensation TPA. Liability policies are written on a deductible basis. The successful broker will be assisting Greenville Utilities in requesting proposals for this service.
- 3. Provide a copy of the 2017 proposal presented by the incumbent broker outlining the current coverage, retention and premiums. This will reflect the program design and help us create the most competitive pricing?
 - A. We are not requesting plan pricing as a part of this RFP, only broker qualifications and a set fee for broker services.
- 4. Provide the property, auto and equipment schedules for our risk management evaluation?
 - A. Greenville Utilities Commission insured \$273,862,657 in property, 329 power units including trailers, and \$5,636,323 in equipment in 2017. Our 2016 audited payroll totaled \$26,107,332.
- 5. Provide the updated loss runs for the last five or more years for our risk management analysis to determine the services (and costs) to be provided?
 - A. A risk management analysis for claims made is not being requested in this proposal.
- 6. How many vendors will require certificates of insurance?
 - A. We are currently managing approximately 100 vendor COIs.
- 7. Estimated number of certificates of insurance needed annually?
 - A. Our business partners request a Greenville Utilities COI approximately 20 times within a year.
- 8. On a percentage basis, how will proposal be evaluated?
 - a. Qualifications and Experience (25%)

 - A. Greenville Utilities Commission is exploring the use of drones and may need coverage for this exposure in the upcoming year.
- 10. Page 12 Section 3 Scope of Services, items: 3.3.4 Claims & Loss Support and 3.3.5 Risk Control can you give an approximation of the extent of utilization for each over each of the last 3 years?
 - A. Minimal Risk Control services have been utilized in the past 3 years. Our past utilization of Claims and Loss Support services has been moderate but is increasing. We will require ongoing Claims and Loss Support into the future.
- 11. Page 8 Section 2.3 references information will be posted to the Internet at www.guc.com -- can you be more specific? (will it show up under 'Doing Business With Us Bids as an addendum in one of the columns or a revised RFP?)

 - A. Property and Boiler/Machinery are insured through two separate policies.
