The Project consists of the addition of secondary clarifiers, return activated sludge pumping, and appurtenances to the GUC Wastewater Water Treatment Plant.

Bids will be received for a single prime Contract. Bids shall be on a lump sum basis, with additive alternate bid items as indicated in the Bid Form.

The project must fully comply with the EDA Contracting Provisions for Construction Projects which are included in the Bidding Documents.
